Dear friends of IFHOH,

World Hearing Day is fast approaching - - On 3 March 2023 we once again celebrate our enduring community of hard of hearing people all over the planet! The World Health Organization (WHO) estimates that currently more than 1.5 billion people (nearly 20% of the global population) live with hearing loss. 430 million of them have disabling hearing loss. It is expected that by 2050, there could be over 700 million people with disabling hearing loss. Of course, a number of these persons identify as Deaf, having sign language as their principal language, but the largest group by far are hard of hearing people...

That is a lot of people that IFHOH is working at bringing together as a community! It is a community made up of so many nationalities, cultures, ethnicities, orientations, and so on. And yet, whenever we share our stories about hearing loss, it always feels as if we are all speaking a common language. We instinctively understand that our stories are built around a shared experience. Embracing our hearing disability together is an ennobling marker of kinship. 
This year's theme:

The World Health Organization has designed World Hearing Day 2023 to highlight the importance of integrating ear and hearing care within primary care, as an essential component of universal health coverage. The key messages of this initiative are as follows:

- Ear and hearing problems are among the most common problems encountered in the community.
- Over 60% of these can be identified and addressed at the primary level of care.
- ↓ Integration of ear and hearing care into primary care services is possible through training and capacity building at this level.
- Such integration will benefit people and help countries move towards the goal of universal health coverage.



On 3 March 2023, the World Health
Organization (WHO) will launch a new training manual
under the title, *Primary Ear & Hearing Care Training*Manual. This publication will be supported by a trainer's
handbook, and other community-focused resources. To

The communication objectives are:

 to draw attention of decision makers in governments and civil society groups towards the WHO's recommendations regarding integration

of ear and hearing care into primary health care (PHC),

- Encourage governments to integrate primary ear and hearing care into training programs for health care providers at primary level,
- Call attention of primary level health care providers (health workers and physicians) towards the needs of people with hearing loss and ear disease, and
- ♣ Inform people about the importance of ear and hearing care and encourage them to seek services.

IFHOH, its partners and stakeholders, are encouraged to:

- raise awareness and to advocate about the importance of ear and hearing care,
- encourage communities and individuals to seek appropriate services, and
- encourage policymakers to integrate ear and hearing care within primary health care.
